

Covid cases: One lakh and counting

SEVERAL MEMBERS from the BJP headquarters in the state, sadhus of the Bochasanwasi Akshar Purushottam Swaminyan (BAPS) sect and employees of Navneet publishing house were among those who tested positive on Thursday, taking the state tally to over one lakh mark.

Paresh Patel, office secretary of Gujarat BJP's state headquarters in Gandhinagar, tested positive Thursday following which he has quarantined himself at home. A BJP leader said that the party was considering whether to allow party workers in large numbers at the headquarters.

In the last week hundreds of workers have been thronging the party office to greet newly appointed party president C.R. Patil. Many have also met Patil, also popularly known as Mama. As Patel's test returned positive, testing of all the workers working at the headquarters was done on Thursday of which around three more were reported to be positive.

Ahmedabad which makes up 30 per cent of the state's total cases, crossed 31,000 mark on Thursday. Following antigen testing of 150 priests at BAPS temple in Shahibnagar over a span of two days, 28 turned out to be positive.

Employees of publishing house - Navneet Education Limited - were also tested, from where nine turned out to be positive. 93 construction sites across the city were served notices after labourers tested positive. Ahmedabad Municipal Corporation (AMC) also declared an orphanage - Shreyas Foundation Anantash Ashram - as well as floor in the Gujarat Gas office in Thaltej as a micro containment zones.

Amreli district got its own Covid-19 testing laboratory on Thursday. Amreli district collector Ayush Oak formally inaugurated the facility at Shantabha Medical College and General Hospital (SMCGH) in Amreli town. An official release said that the laboratory would have the capacity to test an average of 200 samples per day.

SMCGH is the third private medical college in Saurashtra to set up its own Covid-19 testing facility. So far, samples of patients from Amreli were sent to Bhavnagar for Covid-19 testing and results used to take a day or two. But now, they will be available in six hours, the release further said.

The testing will be free of cost. The government will bear the expenses while infrastructure will be provided by the Trust. Amreli collector told The Indian Express while referring to Gujarat Trust which now runs the hospital.

HUSBAND, MOTHER-IN-LAW BOOKED

Vadodara: Woman 'assaulted' for seeking help to make dinner

Vadodara: Vadodara police booked a man who allegedly assaulted his wife on Wednesday, when the woman asked him to help her cook dinner. The man's mother was also booked in connection with the case.

According to the complaint filed by the woman at the Gorwa police station, the incident occurred when she told her husband that cooking dinner had been delayed because she was engaged in other house hold chores throughout the day and if he could chop vegetables for the dinner. According to

the complainant, the husband was angered by the wife's suggestion that he picked up an iron rod lying near him and bashed her with it. "The iron rod was allegedly picked through her foot. The local residents, who reached there after hearing her screams, rushed the woman to a private hospital, where she is undergoing treatment," said an official of Gorwa police station.

The police are on the lookout for the mother and the accused who have absconded after the incident. ENS

IIMA student on campus tests positive

THE INDIAN Institute of Management (IIM) Ahmedabad has reported its first case of Covid-19 among the students pursuing Post Graduate Programme in Management for Executives (PGPX) course. Most of the 140 PGPX students recently came to live on the campus citing accommodation and internet connectivity issues.

A student of the one-year full-

time PGPX course who recently returned to stay on the campus Ahmedabad tested positive this week, IIMA confirmed. However, the institute did not share any more details about the student.

Classes are conducted online and the institute stated that it would continue to do so till the Central government lifts restrictions. In a communication, the IIMA said, "These are individuals with about eight years of work experience who gave up their jobs to be part of the programme. In a normal situation,

they give up their jobs and vacate the rental apartments in the cities where they were working and shift to the campus."

However, during the pandemic, though they had resigned from their jobs, they were forced to continue staying in their rented apartments as they were unable to shift to the campus, the communication added. This increased the cost of living as they were paying rent whilst not employed. Landlords too have been putting pressure on them to vacate or sign an 11-month lease, which would

be inappropriate given that they would have to leave the apartment once classes resume on campus," the authorities stated.

According to IIMA, the institute allowed the PGPX students to come to campus "in groups of a few-day to space out the arrivals" and "accommodate" their hardship. On arrival, they were tested for symptoms and required to self-quarantine for 10 days.

In response to questions emailed by The Indian Express, the institute stated that all safety norms were being observed.

HEALTH SECY'S AFFIDAVIT BEFORE HC

'835 of 40k workers who returned to Surat tested positive'

OF THE 40,414 migrant labourers working in the diamond, textile and GIDC industries who were returned to Surat after the Covid-19 lockdown, 835 people tested positive. Principal Secretary, Health, Jayanti Ravi told the Gujarat High Court on Thursday in an affidavit.

She also submitted that a special call centre has been set up for follow-up of returned labourers.

According to Ravi's affidavit, de-

tails of passengers debarking at Surat railway station is updated daily and then verified via the call centre setup.

The list is forwarded to field officers who test them. As per the health department, 19,000 passengers have arrived at Surat station, of whom 6,714 were detected to be positive. Sixteen among them have tested positive. Ravi also submitted that 2,401 symptomatic passengers at central and Adajan bus depots were also tested, of whom 41 tested positive. Interception of ve-

hicles and random testing is also done at five other entry points to Surat, wherein 85 have tested positive among 6,480 who were tested.

The submissions came following an order by the HC last month wherein a division bench had sought details on measures being taken in Surat to control the outbreak. The bench, in its order of August 17, had also directed that all status reports on the Covid-19 situation are to be filed by the principal health secretary and as an affidavit, on oath henceforth.

Following the court directive, the Health Department issued an order dated August 26, formed a team of IAS officers to take stock of all the civil hospitals across the state. They are and were to submit a report by Friday.

The court is due to hear a bunch of public interest litigations on Covid-19 related issues on Friday. Ravi sought time of two more weeks to file the report instead of Friday, owing to paucity of time. Ravi is camping in Rajkot, from where an increasing number of cases are being reported.
