The accused, Pradipchandra Parmar, a Grade 1 – Class C auditor, demanded Rs 7,000 from the complainant to provide him the annual audit report. The complainant has an agricultural co-operative society in Godhra and approached Parmar for an year end audit report.

The complainant approached the Godhra Anti-Corruption Bureau (ACB), following which they nabbed Parmar accepting the bribe of Rs 7,000 near an automobile showroom on the Godhra-Lunawada high road. **ENS**

A SESSIONS court on Monday framed charges against two persons in the 2002 Best Bakery case. Harshad Solanki and Mafat Gohil will face trial for charges, including murder, attempt to murder, rioting and other sections of the Indian Penal Code for the communal violence in Vadodara in 2002.

During the violence in the bakery, 14 persons were killed.
