

19-yr-old woman set Section 144 in Dumka

Dumka Sub-Divisional Officer Mahaeshwar Mahato said Section 144 of the IPC has been invoked in the town area. In a statement, Mahato said: "Without any prior permission all public gathering including protests, religious processions is restricted."

The woman had been admitted to Phoolo Jhano Medical College Hospital in Dumka and was later referred to Ranchi's Rajendra Institute of Medical Sciences, where she died.

RIMS spokesperson Dr Rajiv Ranjan said: "(The) patient had suffered 45 per cent burn injuries and the cause of her death is cardio-respiratory failure."

Dumka Deputy Commissioner RS Shukla said: "We have recommended a speedy trial and have given a compensation of Rs 1 lakh to the victim's family. We are in the process of getting the family more compensation... The accused used to harass the woman. The authorities did not know this because the family never complained."

The woman's father told *The Indian Express*: "It was around 4 am when we heard her scream-

ing. We rushed to her room and doused the fire. She said Shahrukh had done this. She died between Saturday and Sunday."

Former chief minister and BJP leader Raghubar Das attacked Chief Minister Hemant Soren over the incident. "An accused named Shahrukh set her on fire by pouring petrol, but the CM has not uttered a word. What is this, if not appeasement. And the CM is sending the perpetrator (of Ranchi violence in the aftermath of comment against Prophet) via air ambulance. After Soren became CM, jihadi forces have become active. The instances of love-jihad issue have increased."

Ready to hand over Phogat death case to CBI if necessary: Goa CM

GOA CHIEF Minister Pramod Sawant on Sunday said his government was ready to hand over the probe into the death of Haryana BJP leader and actor Sonali Phogat to the CBI, if necessary.

Sawant, who holds the Home portfolio, said, "The Chief

Minister of Haryana called me personally yesterday. He said her (Phogat) family members had met him. He requested that if necessary the case should be handed over to the CBI. The Goa government is open to hand over the case to the CBI. The necessary investigation is being carried out in the case but as requested by the Haryana CM, if the need arises, we are prepared to hand over the case to the CBI."
